**CREATION OF THE LOCAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE  
AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC)**

**WHEREAS**, Republic Act No. 9208 declares that the State shall give highest priority to the enactment of measures and development of programs that will promote human dignity, protect people from violence and exploitation, eliminate trafficking in persons and mitigate pressures for involuntary migration and servitude of persons to ensure their recovery, rehabilitation and reintegration.

**WHEREAS**, Republic Act No. 9262, on the other hand, underscores the commitment of the State on safeguarding the dignity of women and children while guaranteeing full respect of their human rights and to protect them from violence and threats to their personal safety and security.

**WHEREAS**, Joint Memorandum Circular No. 2010-1 of the Department of the Interior and Local Government (DILG) and the Department of Social Welfare and Development (DSWD) and the Department of Justice (DOJ) directs the creation of a Committee on Anti-Trafficking and Violence against Women and their Children (LCAT-VAW) to strengthen local structure that will collaboratively address the problem of Trafficking and Violence against Women and Children;

**NOW, THEREFORE, I, CELIA T. LAYUS, M.D.** Municipal Mayor of Claveria, Cagayan, by virtue of the powers vested in me by law and the sovereign will of the people, do hereby order the creation of the Local Committee on Anti- Trafficking and Violence against Women and Children (LCAT-VAWC) as follows

**SECTION I - COMPOSITION**

**SECTION II - DUTIES AND FUNCTIONS**

1. Institute policies and programs to protect women and children who are victims of trafficking and violence (formulates local ordinances and resolutions.)
2. Create and establish system on surveillance, investigation and rescue to ensure effective and efficient coordination.
3. Undertake information, education and advocacy campaign against trafficking in persons and VAWC.
4. Monitor and oversee the strict implementation of RA 9208, RA 9262 and other related laws for the protection of women and children.


**SECTION III - SECRETARIAT**

**SECTION IV - EFFECTIVITY**


This Order shall take effect immediately.
