**EXECUTIVE ORDER CREATING THE MUNICIPAL COUNCIL FOR CULTURE AND THE ARTS (MCCA) IN THE MUNICIPALITY OF CLAVERIA, PROVINCE OF CAGAYAN.**

**WHEREAS**, the Municipal Government of Claveria recognizes the important role of Culture and the Arts in shaping the Municipality's history;
