**REORGANIZING THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF  
CLAVERIA, CAGAYAN**

**WHEREAS**, the code adopts the provisions of Republic Act 6975 Department of Interior and Local Government that pertains to the extent of operational supervision and control of Local Chief Executive over the Police force, fire protection unit and jail management personnel;


**WHEREAS**, RA 6975 provides for the creation of PLEB in every Municipality which shall be composed of one member of the Sangguniang Bayan, Punong Barangay, to be chosen by the Liga ng mga Barangay, and three members of NGOs selected by the Peace and Order Council;

**WHEREAS**, there is a need to re-organize the People's Law Enforcement Board of Claveria, Cagayan to wit;

**EXECUTIVE ORDER CREATING THE MUNICIPAL COUNCIL FOR CULTURE AND THE ARTS (MCCA) IN THE MUNICIPALITY OF CLAVERIA, PROVINCE OF CAGAYAN.**
