**AN EXECUTIVE ORDER RE-ORGANIZING THE MAMAMAYANG AYAW SA ANOMALYA, MAMAMAYANG AYAW SA ILIGAL NA DROGA (MASA MASID) STEERING COMMITTEE AND TECHNICAL WORKING GROUP**

**WHEREAS**, R.A 9165 also known as the "Comprehensive Dangerous Drug Act of 2002" protects the State and its inhabitants from possible harms brought upon by illegal drug substances and supports the unrelenting campaign against illegal drugs thru effective enforcement of anti-drug policies, programs and projects;

**WHEREAS**, the Philippine Constitution of 1987 encourages the participation of civil society organizations that promote the welfare of the nation;

**WHEREAS**, DILG MC No. 2016-116 dated 2 September 2016 enjoins the implementation of the MASA MASID project thru the organization of the Expanded UBAS Municipal Technical Working Group and the MASA MASID Teams in affected barangays;

**WHEREAS**, DILG MC No. 2017-112 dated 29 August 2017 provides for the Revised Guidelines on the Implementation of the MASA MASID;

**WHEREAS**, the MASA MASID Program is a community -based initiative to engage volunteers in the fight against criminality, corruption and illegal drugs that shall adopt multi-sectoral and mass-based approach to ensure effective war against corruption and illegal drugs.

**WHEREAS**, the MASA MASID Program encourages active people's participation on the monitoring and evaluation of the implementation of government-funded projects;

**WHEREAS**, the organized MASA MASID Teams shall report to proper authorities all illegal incidents including, but not limited to, illegal drug-related incidents, syndicated crimes, corruption within government offices among others.

**NOW, THEREFORE, I, Celia T. Layus, MD.**, Municipal Mayor of Claveria, Cagayan, by virtue of the powers vested in me by law do hereby order the organization of Municipal MASA MASID Steering Committee and Technical Working Group with the following composition:

**SECTION 4. RESPONSIBILITIES OF THE TWG**

1. Established the MSA MASID modes of reporting in the municipal level and put in place an effective reporting mechanism to ensure that reports are properly acted upon;
2. Consolidate reports coursed through the modes of reporting, validate submitted reports and refer to concerned agencies if needed;
3. Organize and mobilize the MASA MASID Teams;
4. Organize and mobilize the MASA MASID Volunteers;
5. Ensure the effective implementation of MASA MASID Activities; and
6. Provide effective and regular monitoring and evaluation mechanism.

**SECTION 5. FUNDING AND OTHER SUPPORT**

Pursuant to Section 51 of the Comprehensive Drugs Act of 2002, the LGUs shall appropriate a substantial portion of their respective annual budgets to assist in or enhance the enforcement of the Act giving priority to preventive or educational programs and the rehabilitation or treatment of drug dependents




