EXECUTIVE ORDER NO. 001-2018

AUTHORIZING THE IMPLEMENTATION OF THE THIRD TRANCHE COMPENSATION ADJUSTMENT FOR LOCAL GOVERNMENT PERSONNEL PURSUANT TO LOCAL BUDGET CIRCULAR NO. 115 DATED JANUARY 3, 2018; GRANT OF STEP INCREMENT DUE TO LENGTH OF SERVICE PURSUANT TO CSC-DBM JOINT MEMORANDUM CIRCULAR NO. 1, S-2012 AND GRANT OF STEP INCREMENT TO ELECTIVE OFFICIALS BASED ON LENGTH OF SERVICE PURSUANT TO CSC-DBM JOINT MEMORANDUM CIRCULAR NO. 1 DATED JANUARY 27, 2016

WHEREAS, a lump sum appropriation was proposed in the 2018 Annual General Fund Budget of the Municipality of Claveria for the implementation of the Third Tranche Compensation Adjustment for government personnel pursuant to Executive Order No. 21 subject to definite guidelines yet to be issued by the Department of Budget and Management; Grant of Step Increment due to Length of Service pursuant to CSC-DBM JMC No. 1, S-2012 and Grant of Step Increment to Elective Officials based on Length of Service pursuant to CSC-DBM JMC No. 1 dated January 27, 2016;

WHEREAS, Appropriation Ordinance No. 03, S-2017 authorizing the Annual General Fund Budget of the Municipality of Claveria, Cagayan was approved by the Local Sanggunian on October 11, 2017 and consequently approved by the Sangguniang Panlalawigan in its Resolution No. 2017-09-663 dated December 13, 2017;

WHEREAS, Local Budget Circular No. 115 dated January 3, 2018 was issued by the Department of Budget and Management for the implementation of the Third Tranche Compensation Adjustment for Local Government Personnel;

NOW, THEREFORE, by virtue of the powers vested in me as the Local Chief Executive, I CELIA T. LAYUS, MD., do hereby authorize the implementation of the Third Tranche Compensation Adjustment for Local Government Personnel pursuant to Local Budget Circular No. 115 dated January 3, 2018 issued by the Department of Budget and Management ; Grant of Step Increment due to length of service pursuant to CSC-DBM Joint Memorandum Circular No. 1, S-2012 and Grant of Step Increment to elective officials based on length of service pursuant to CSC-DBM Joint Memorandum Circular No. 1 dated January 27, 2016, effective immediately.
