EXECUTIVE ORDER NO. 03A

CREATING THE MUNICIPAL TECHNICAL WORKING GROUP (TWG) FOR THE FORMULATION OF THE FOREST LAND USE PLAN (FLUP)

WHEREAS, Republic Act 7160 of the Local Government Code of 1991 and consistent with local autonomy and decentralization, the provision for the delivery of basic services and facilities are now devolved to the LGUs from the national government,

WHEREAS, the virtue of the Presidential Decree 1152 (Philippine Environmental Policy), Presidential Decree 984 (Pollution Control Law), the Solid Management Act, and the Republic Act 9003 mandates LGUs to manage their environment sound;

WHEREAS, LGU-Claveria has entered into an agreement with the Department of Environment and Natural Resources as its partner in the attainment of sustainable development for the forests and forestlands of the municipality;

WHEREAS, there is a need to formulate a work plan that will provide focus, direction, and guidelines to achieve the goals of the project;

NOW THEREFORE, I, CELIA T. LAYUS, MD, Municipal Mayor of Claveria, Cagayan, by virtue of powers vested in me by law, do hereby create a Municipal Technical Working Group (TWG) for the formulation of Forest Land Use Plan (FLUP) for the Municipality of Claveria, Cagayan assisted by the DENR.

- a. Attend or conduct technical training to enhance capability of TWG and stakeholders;
- b. Formulate work and financial plan for the project;
- c. Participate actively on resource data collection, mapping and situational analysis;
- d. Review documents or plans and assess the current status of forest management practices, programs, policies of the municipality;

e. Facilitate broad-based consensus on the short- and long-term strategies of the LGU on forest management;


f. Assist and facilitate in the formulation of strategic short-term action plan based on multi-sectoral to achieve the goals of sustainable forest management; and

g. Develop information, education, and campaign to promote Forest Land Use planning.
