EXECUTIVE ORDER NO. 04  
Series of 2020

**“AN ORDER DECLARING THE SUSPENSION OF CLASSES IN SELECTED SCHOOLS IN CLAVERIA, CAGAYAN DUE TO COVID-19, ON MARCH 16-20, 2020”**

**WHEREAS**, section 15 of Article II of the 1987 Constitution States that the State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, DILG Central Office issued an Advisory dated March 10, 2020 mandating all Local Chief Executives to strengthen preventive measures to mitigate the effects and impact of COVID-19 to the community;

**WHEREAS**, the Inter-Agency Task Force for the Management of Emerging Infections Disease adopted Resolution No. 11 Series of 2020 March 12, 2020 approves that Philippines is under Code Red Sublevel two (2) thus; suspension of classes;

**WHEREAS**, it was reported from Municipal Health Office that there were Persons Under Investigations (PUI's) cases in Barangay Centro 1 coming from affected country;

**WHEREAS**, it was unanimously recommended by the Municipal Inter-Agency Task Force COVID-19 to the establish precautionary measures to mitigate the effect of COVID-19;

**NOW, THEREFORE**, I, **CELIA T. LAYUS, M.D.** Municipal Mayor, Claveria, Cagayan by virtue of powers vested in me by the Constitution and the laws, do hereby order the following;

**SECTION 1.** Suspension of Classes. Suspend Classes on March 16-20 2020 at Academy of Saint Joseph (ASJ); Claveria School of Arts and Trade (CSAT) and Claveria Central School; all situated in Barangay Centro 1, Claveria, Cagayan where reported cases of PUIs;

**SECTION 2.** Monitoring and Reporting. The Municipal Health Office in coordination with Barangay Health Emergency Response Team shall closely monitor the result of the swab test of the identified PUIs and provide updates to the office of the Mayor;

**SECTION 3.** Repealing Clause. All prior issuances and parts thereof inconsistent with this Executive Order are hereby repealed as amended or otherwise modified accordingly.

**SECTION 4.** Effectivity. This Executive Order shall take effect immediately.
