ReORGANIZING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL OF CLAVERIA, CAGAYAN

WHEREAS, Republic Act No. 10121 otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010" was enacted to strengthen development of policies and plans and the implementation of actions and measures concerning all aspects of disaster risk reduction and management;

WHEREAS, Republic Act 10121 directs the strengthening of Local Government capacities on disaster risk reduction and management through decentralization of powers, responsibilities and resources;

NOW THEREFORE, I, **CELIA T. LAYUS**, Local Chief Executive of Claveria, Cagayan, by the power vested in me by law do hereby order and direct the following;

Section 1: Pursuant to Republic Act 10121, the Municipal disaster Coordinating Council shall come to cease and shall henceforth be replaced by the Municipal Disaster Risk Reduction and Management Council to become composted as follows:

Section

2: The council shall perform the following functions:

1. Approve ,monitor and evaluate the implementation of the Local Disaster Risk Reduction and Management Plan and annually review,test and develop the plan consistent with other national and local planning programs.
2. Ensure the integration of Disaster Risk Reduction and Climate Change Adaptation into Local Development programs as a strategy in sustainable development and poverty reduction.
3. Recommend the implementation of forced or preventive evacuation of local residents,if necessary, and
4. Convene once every three (3) months,as necessary.

Section 3: Effectively, this executive order shall take effect immediately.
