EXECUTIVE ORDER NO. 15

AN EXECUTIVE ORDER DESIGNATING MR. HAROLD JOSEPH A. VILLANUEVA, MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICER (MSWDO) AS THE FOCAL PERSON ON THE OPERATION OF BALAY SILANGAN IN, CLAVERIA, CAGAYAN

WHEREAS, Section 77 of Republic Act No. 9165, or the Comprehensive Dangerous Drugs Act of 2002, as amended (the "Act"), provides that the Dangerous Drugs Board (the "Board") to be the policy-making and strategy-formulating body in the field of drug prevention and control;

WHEREAS, Section 84 (a) of the Act provides for the Philippine Drug Enforcement Agency ("PDEA") to: "Implement or cause the efficient and effective implementation of the national drug control strategy formulated by the Board thereby carrying out a national anti-drug campaign with the assistance of concerned government agencies";

WHEREAS, Section 51 of the Act mandates that Local Government Units ("LGUs") shall "appropriate a substantial portion of their respective annual budgets to assist in or enhance the enforcement of the Act giving priority to preventive or educational programs and the rehabilitation or treatment of drug dependents.";

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular (MC) No. 2009-09 (Subject: Unified Actions Against Illegal Drugs and other Substances), which mandates that it is a principal responsibility of local authorities to support overall government efforts to address illegal drugs and other substances

WHEREAS, the National Oversight Committee under DDB Regulation No. 2 created a "BALAY SILANGAN" who will serve as an instrument for the reformation of drug personalities;

WHEREAS, the "BALAY SILANGAN" was established as per requirement in the declaration of a Drug-cleared municipality upon recommendation by the Regional Oversight Committee.

NOW, THEREFORE, I, **CELIA T. LAYUS, M.D.**, Mayor, Claveria, Cagayan, do hereby order;

Section 1. Designation of BALAY SILANGAN Focal Person. **MR. HAROLD JOSEPH A. VILLANUEVA**, MSWDO, is hereby designated as the focal person for "BALAY SILANGAN" in the municipality of Claveria, Cagayan.

Section 2. Duties and Functions of Focal Person. The duties and functions of a BALAY SILANGAN focal person are the following;

- a. Oversee the operation of the established BALAY-SILANGAN which will serve the instrument for the reformation of drug personalities;

- b. Assist the Anti-Drug Abuse Council in the implementation of Drug Reformation Programs under Section 8 of DDB Regulation No. 02 series of 2018;
- c. Assist the service providers/stakeholders in the implementation of Drug Reformation Programs;
- d. Recommend to the office of the Mayor upon concurrence by the members of ADAC the budgetary requirements on the operation of the said facility.
- e. Perform other functions as directed by the LCE in accordance with existing laws, rules and regulations.

Section 3. Effectivity. This Executive Order is effective immediately.
