EXECUTIVE ORDER NO. 19 Series of 2020

REITERATING THE HEALTH AND SAFETY GUIDELINES GOVERNING THE OPERATIONS OF ACCOMMODATION ESTABLISHMENTS AND OTHER TOURISM ENTERPRISES UNDER THE NEW NORMAL SET-UP

WHEREAS, the National Inter-Agency Task Force for the Management of Emerging Infectious Diseases has issued Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of October 08, 2020;

WHEREAS, the Department of Tourism has issued Administrative Order no. 2020-002 prescribing the guidelines on the operation of Hotels and other Accommodation Establishments under the new normal, Memorandum Circular No 2020-003 prescribing the Health and Safety Guidelines Governing the Operations Of Tourist Land Transport Services under the New Normal, Memorandum Circular No 2020-004 prescribing the Guidelines Governing the Operations Of Dot-Accredited Restaurants under the New Normal, Memorandum Circular No. 2020-005 prescribing the Interim Guidelines for Applications for Accreditation, Administrative Order No.2020 - 006 Guidelines on Accommodation Establishments for Stay-cation Purposes Under a General Community Quarantine; Administrative Order no. 2020 - 007 prescribing Guidelines on the Operations of Travel and Agencies and Tour Guides Under a Community Quarantine; and Memorandum Circular No. 2020 - 007 prescribing Health and Safety Guidelines Governing the Operation of Island and Beach Destinations under the New Normal;

WHEREAS, the Department of Trade and Industry has issued guidelines on the minimum health protocol for dine-in restaurants and fast-food establishments under the new normal;

WHEREAS, despite the need to keep its tourism industry thriving, the municipal government is still expected to act as stewards of the general health and welfare of its people and tourists alike;

NOW, THEREFORE, by the authority vested in me as Municipal Mayor by the Constitution and the laws of the Republic of the Philippines, I, **Celia T. Layus,MD.**, do hereby order:

SECTION 1. ADOPTION. The following issuances are hereby adopted:

1.1 Department of Tourism Administrative Order. 2020-002 Prescribing the Health and Safety Guidelines on the Operation of Hotels and Other Accommodation Establishments under the New Normal;

1.2 Department of Tourism Memorandum Circular No. 2020-003 Prescribing the Health and Safety Guidelines on the Operation of Tourist Land Transport Services under the New Normal;

1.3 Department of Tourism Memorandum Circular No. 2020-004 Prescribing the Health and Safety Guidelines on Operations of DOT-Accredited Restaurants under the New Normal;

1.4 Department of Tourism Memorandum Circular No. 2020-005 Prescribing the *Interim Guidelines for Applications for Accreditation*;

SECTION 2. CREATION AND COMPOSITION OF THE JOINT INSPECTION and MONITORING TEAM

2.1 To effectively monitor the implementation of these minimum health and safety guidelines and to ensure that tourism establishments are adhering to these set protocols, each city/municipal LGU shall create a city/municipal joint inspection and monitoring team.

2.2 The Joint Inspection and Monitoring Team shall be composed of the following members:

- a) CityMunicipal Tourism Officer or his/her representative; - **(Randolph Elizer G. Simon)**
- b) City/Municipal Health Officer or his/her representative; - **(Milrose F. Tangonan, MD)**
- c) City/Municipal Business Permit and Licensing Office representative; - **(Manuel Molina)**
- d) City/Municipal Sanitary Officer; - **(Hazel Calumpit)**
- e) City/Municipal Disaster Risk Reduction and Management Office representative; - **(Jason Sacro)**
- f) City/Tourism Council representative; - **(Remar Agcaoili)**
- g) Cagayan Tourism Office representative; - **(Jenifer T. Junio, EnP)**
- h) Department of Tourism representative; - **(Thomas Santos)**
- i) Department of Trade and Industry representative; - **(Ivy Grace Domingo)**
- j) Philippine National Police representative; - **(PMaj. Edwin Aragon)**
- k) Department of Labor and Employment representative; and – **(PESO Jeffrey L. Salmon, CPA)**
- l) Department of the Interior and Local Government representative – **(Victor Santos, MLGOO)**

SECTION 3. SEPARABILITY CLAUSE. If, for any reason, any part or provision of this Order shall be found unconstitutional or invalid, other parts or provisions thereof which are not affected thereby, shall continue to be in full force and effect.

Section 4. REPEALING CLAUSE. Previous issuances or parts thereof in conflict with or inconsistent to the provisions of this Executive Order are hereby repealed or modified accordingly.

Section 5. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately.
