**Executive Order No. 13**  
**Series of 2021**

**AN ORDER IMPOSING LOCALIZED CONTAINMENT (LOCKDOWN) MEASURES OF PUROK 4 and PUROK 6 of BRGY. CENTRO VII, CLAVERIA, CAGAYAN FOR PURPOSES OF CONTAINING THE SPREAD OF COVID-19.**

WHEREAS, the Municipality of Claveria is currently under Modified Enhanced Community Quarantine (MECQ) pursuant to the classification and declaration of the National Inter-Agency Task Force for Emerging Infectious Disease;

WHEREAS, as of June 20, 2021, there are twenty-five (25) new confirmed cases of COVID-19 thereby bringing the total number of positive COVID-19 Cases in the Municipality to one hundred ninety-four (194) with one hundred seven (107) recoveries and four (4) deaths;

WHEREAS, the sudden turn out of new positive COVID-19 cases is very much alarming. With the reported new confirmed COVID-19 cases, together with the number of suspected and probable cases of COVID-19, the Local Government Unit of Claveria, Cagayan, together with the concurrence of the Municipal Inter-Agency Task Force (MIATF) may put some areas under localized containment (lockdown) for a certain period;

WHEREAS, Article II, Section 15 of the Constitution provides that the state shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 16 of Republic Act 7160 , otherwise known as the Local Government Code of 1991, provides that within their respective territorial jurisdictions, local government units shall, among others, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, that on June 24, 2021, the Municipal Inter- Agency Task Force (MIATF) Against COVID-19 has convened and recommended to the Municipal Mayor the implementation of a localized lockdown of Puroks 4 & 6 of Brgy. Centro VII and in order to contain the spread of the COVID-19 virus.

**NOW, THEREFORE, I, CELIA T. LAYUS, M.D.**, Municipal Mayor of Claveria, Cagayan, by virtue of the power vested in me by law, do hereby order that a localized containment (lockdown) measures be imposed in Purok 4 & 6 of Brgy. Centro VII with the following:

**I. GUIDELINES**

**A. DURATION**

The localized containment shall be for a period of fourteen (14) days beginning 8:00 o'clock in the morning of June 25, 2021 up to 8:00 in the morning of July 8, 2021.

**B. MANDATORY HOME QUARANTINE**

All residents affected shall be strictly advised to stay inside their respective residences.

Only emergency cases which require immediate medical and hospital attention are exempted from this Order.

**C. CONTINUOUS CONTACT TRACING**

The Municipal Health Office shall conduct a continuous contact tracing for COVID-19 positive cases.

**D. MAINTENANCE OF PEACE AND ORDER**

The Municipal Inter-Agency Task Force (MIATF) against COVID-19, PNP and Barangay Officials shall implement this Order.

**E. PROVISION AND DISTRIBUTION OF GOODS**

The Municipal and Barangay Government shall provide assistance in the food and medical needs of the affected residents for the duration of the localized containment (lockdown).

**II. IMPOSABLE PENALTIES**

Any person who knowingly violate any provision of this Order and other health and safety protocols issued by the Department of Health and other authorized rule-making agencies will face the appropriate administrative and/or criminal penalties.

**III. AMENDMENTS**

This Executive Order may be amended from time to time, as the needs arises, or if there is a change in the situation as reported by the Municipal Inter-Agency Task Force (MIATF) against COVID-19.

**IV. EFFECTIVITY CLAUSE**

This Order shall take effect immediately.
