ORDINANCE NO. 01 – 2016

AN ORDINANCE CELEBRATING EVERY LAST FRIDAY OF SEPTEMBER AS THE OFFICIAL TEACHERS' DAY IN THE MUNICIPALITY OF CLAVERIA, CAGAYAN AND APPROPRIATING FUNDS THEREOF.

Section 1. **Short Title** – This ordinance shall be known as **“TEACHERS’ DAY ORDINANCE IN THE MUNICIPALITY OF CLAVERIA, CAGAYAN”**.

Section 2. **Declaration of Policy** – It is a declared policy of this municipality to recognize the role of teachers for their genuine and noble commitment for the holistic development particularly the education of the youth.

Section 3. **Definition of Terms** – As used in this Ordinance the following shall mean:

Teachers - all teaching and non teaching personnel, in the field of their expertise whether in private and public schools in the municipality of Claveria.

Elementary School – educational learning institution which provides education for children from Kinder to Grade 6.

Secondary School – educational institution which provides education for children from Grade 7 to Grade 12.


Public School - educational institution which is administered and operated by the government.

Private School - educational institution which is administered and operated by the private sector, private individual or corporation.

Section 4. **Objectives.** Declaration of the Municipal Teachers Days shall have the following objectives:

OBJECTIVES:

- a. To encourage intensive and active participation of teachers in all government programs, projects and activities affecting them and;
- b. To reinforce all government initiatives for the development of education sector;
- c. To broaden and strengthen the services provided by the National Government Agencies, Local Government Unit concerned and private agencies to the people;
- d. To provide information mechanisms on teachers in areas of education, employment, livelihood, physical and mental health and capabilities in team building and networking;



- e. To increase spirit of volunteerism among the teachers of this Municipality, particularly in the maintenance of peace and order, protection of children, preservation and conservation of environment and natural resources within the municipality; and
- f. To provide a venue for active participation of teachers in the community in terms of cultural and eco-tourism awareness programs to be launched by the municipality.

Section 5. **Teachers Day Component.** Under the supervision of the Local Government Unit concerned, the Teachers' Day shall have the following event:

Creation of Teachers Day Committee – several committees shall be formed each year from the group of teachers themselves of this municipality to ensure a successful result of this special day.

One-Day Activity – There shall be a variety of activities such as but not limited to teachers forum, presentation and games most especially the formation of a **Teachers' Organization** among elementary and secondary teachers and in any other activities towards molding the students to become a responsible citizen of this community.

Section 6. **Supervision.** The committee on Local Finance will supervise the implementation of the program especially the disbursement of funds to be utilized.

Section 7. **Funding.** The Municipal Government of Claveria shall appropriate the initial fund amounting to Fifty Thousand Pesos (P50,000.00) for the effective implementation and success of this Ordinance.

Section 8. **Applicability Clause.** All other matters relating to the impositions of this Ordinance shall be governed by pertinent provisions of existing laws and other ordinances.

Section 9. **Repealing Clause.** All ordinances, rules and regulations, or part thereof, in conflict with, or inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.

Section 10. **Separability Clause.** If for any reasons, any section of this ordinance shall be held unconstitutional or invalid, other sections which are not affected thereby shall continue to be in full force and effect.


Section 11. **Effectivity Clause.** – This Ordinance shall take effect immediately.

RESOLVED FURTHER, to send copies of this ordinance to all concerned agencies for their information and implementation and to the Sangguniang Panlalawigan, Cagayan Province for review.




