AN ORDINANCE AMENDING ORDINANCE NO. 002, S - 2017 ENTITLED “AN ORDINANCE ESTABLISHING A BLOOD DONORS’ PROGRAM IN THE MUNICIPALITY OF CLAVERIA.”

Be it ordained that, by the Sangguniang Bayan in a regular session duly assembled, that:

SECTION 1. TITLE – This ordinance shall be known as *“An Ordinance Amending Ordinance No. 002, S - 2017 “An Ordinance Establishing a Blood Donor’s Program in the Municipality of Claveria”.*

SECTION 2. Section 8 shall be amended as follows:

8.2 *Entitled for an incentive package amounting to Five Hundred Pesos (P500.00) to cover transportation and other incidental expenses.*

SECTION 3. SEPARABILITY CLAUSE – If any provision of this ordinance is declared invalid, the provisions not affected thereby shall remain in force and effective.

SECTION 4. REPEALING CLAUSE – Any ordinance, resolution, executive orders or other issuances inconsistent herewith are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY – This ordinance shall take effect upon approval
