ORDINANCE NO. 014, S – 2020

Sponsored by the Committee on Health & Social Services and
Committee on Ordinances & Legal Matters

**COLLECTION OF FEE ON ANTIGEN TEST AVAILED AT THE RURAL HEALTH UNIT OF THE
MUNICIPALITY AND PROVIDING GUIDELINES THEREOF.**

Be it Ordained, by the Sangguniang Bayan of the Municipality of Claveria, in regular session that:

SECTION 1. IMPOSITION OF FEE – There shall be a fee collected amounting to Five Hundred Pesos (₱ 500.00) from every Claveriano who would avail Antigen Test at the Rural Health Unit of Claveria, Cagayan, except those specified to be exempted.

SECTION 2. ADMINISTRATIVE PROVISIONS – The Municipal Health Office shall manage the operation and control of the Antigen Testing, oversee the proper implementation of the ordinance and all the guidelines, rules and regulations relative to its operation and implementation.

1. Free test to all frontline health workers: RHU Personnel, Philippine National Police (PNP), PNP-Maritime, Bureau of Fire Protection (BFP), Mayor's Office, IATF, Philippine Coast Guards, Market Collectors, and to all returning eligible Locally Stranded Individuals (LSIs) and Overseas Filipino Workers.
2. Free testing is also given to all LGU national agencies officials and employees with official travel, provided they have an approved travel order or mission order and Certificate of Appearance.
3. For Private individuals (residents of Claveria only) who will avail of the antigen test at RHU, Five Hundred Pesos (₱ 500.00) will be paid.
4. Antigen testing shall be exclusively to Claverianos only.

SECTION 3. TIME AND MANNER OF PAYMENT – The fee shall be paid to the Municipal Treasurer before the conduct of the antigen testing.

SECTION 4. ACCRUAL OF PAYMENT – The fees collected shall accrue in the trust fund of the Municipality of Claveria and shall be exclusively used for the purchase of testing kits.

SECTION 5. REPEALING CLAUSE – All ordinances, circulars, orders, rules and regulations inconsistent with this ordinance are hereby repealed and or modified accordingly.

SECTION 6. SEPARABILITY CLAUSE – Should any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 7. EFFECTIVITY – This ordinance shall take effect immediately upon approval.


