REQUIRING THE MANDATORY USE OF FACE SHIELD OVER FACE MASK IN THE MUNICIPALITY OF CLAVERIA, CAGAYAN DURING THE COMMUNITY QUARANTINE PERIOD, AND PROVIDING PENALTIES THEREOF.

Be it enacted by the Sangguniang Bayan assembled in session that:

- SECTION 1. TITLE** – This ordinance shall be known as *“The Mandatory Use of Face Shield over Face Mask during Community Quarantine Act of Claveria, Cagayan”*.
- SECTION 2. LEGAL BASES** – The Department of Health issued Department Memorandum No. 2020 – 0534 and consequently LGU – Claveria, Cagayan issued Executive Order No. 01 Series of 2021 for the use of face shield to curb the further spread of COVID-19 virus. Also the DTI and DOLE came up with Joint Memorandum Circular No. 20 – 04 – A Series 2020, requiring the wearing of face shields.
- SECTION 3. REGULATIONS** – Individuals in the following settings shall wear face shields in addition to face mask.
- a. Enclosed public places;
 - b. Places of worship;
 - c. Schools
 - d. Commercial establishments used for business or commercial purposes identified as follows: groceries, shopping centers, public markets.
 - e. Public transportation which may include, but not limited to jeepneys, buses, tricycles; and
 - f. Work places that involve interaction whether verbal or physical contact between and among persons.
- SECTION 4. EXEMPTIONS** – the following individuals shall be exempted from wearing face shield.
- a. Children below two (2) years old;
 - b. Individuals wearing goggles or other barriers for eye protection in their current task or line of work;
 - c. Individuals who are unable to remove face shields on their own-including those who are incapacitated, unconscious or with medical conditions;
 - d. Individuals engaging in any form of health enhancing physical activity;
 - e. Individuals whose safety or ability to work would be seriously and adversely affected by visual or respiratory impairment due to the use of face shield;
 - f. Individuals engaged in strenuous activity or work (construction, logistics) fine workmanship (seamstress), operation of transport vehicles (driving);
 - g. Passengers of motor vehicles wearing helmets with full-face visors;

h. Individuals who are eating and drinking in public places. Face shields must be worn before and after eating and drinking.

SECTION 5. PENALTY – Individuals violating provision of this ordinance shall be fined Five Hundred Pesos (Php 500.00) each violation.

SECTION 6. SEPARABILITY CLAUSE – Any provision of this ordinance be declared invalid by a competent authority shall not affect the validity of such other part which shall continue to be in full force and effect.

SECTION 7. REPEALING CLAUSE – Ordinances, rules and regulations inconsistent herewith are hereby repealed, amended or modified accordingly.

SECTION 8. EFFECTIVITY – This ordinance shall take effect immediately until such time that the community quarantine is lifted.


