

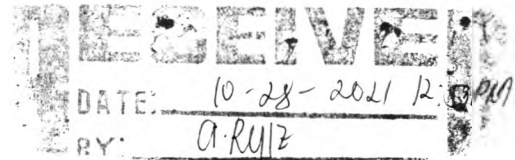

**AMENDING SECTION 3 OF ORDINANCE NO. 2012 -10, ENTITLED "GRANTING STIPEND TO ALL DULY APPOINTED TANOD BRIGADE MEMBERS OF THE COMPONENT BARANGAYS OF CLAVERIA, CAGAYAN, AND PROVIDING FUNDS THEREOF."**

**Be it enacted by the Sangguniang Bayan of Claveria, Cagayan in its regular session assembled, that:**

**Section 1.** Section 3 of Ordinance No. 2012 - 10, as amended by Ordinance No. 03 -2016 "Every qualified member of the tanod brigades shall receive a stipend of Two Hundred Fifty Pesos (P250.00) per month to be given on a quarterly basis. The Municipal Mayor may increase the incentives of the Barangay Tanod Brigades two (2) years hereafter at a rate of not more than twenty percent (20%)", is hereby amended and now to be read as follows:

***"Every qualified member of the tanod brigades shall receive a stipend in the amount of Three Hundred Fifty Pesos (P350.00) per month. The Municipal Mayor shall increase the incentives of the members of the Barangay Tanod Brigades every two (2) years hereafter at a rate of not more than twenty percent (20%)".***

**Section 2.** Effectivity – This ordinance shall take effect starting budget year 2022 and upon compliance of the required posting and publications as provided for under RA 7160.

**ENACTED** this 27<sup>th</sup> day of October 2021 at Claveria, Cagayan.
