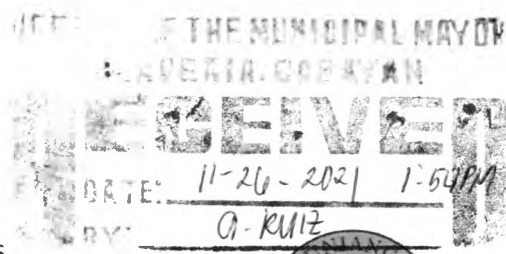

GRANTING INCENTIVES TO ALL QUALIFIED BARANGAY OFFICIALS OF ALL THE COMPONENT BARANGAYS OF THE MUNICIPALITY OF CLAVERIA, CAGAYAN, PROVIDING FUNDS THEREFORE AND FOR OTHER PURPOSES.

WHEREAS, Section 393 of RA 7160 provides that *“barangay officials including barangay tanods and members of Lupong Tagapamayapa, shall receive honoraria, allowances, and such other emoluments as may be authorized by law or city, municipal or barangay ordinance...”*;

WHEREAS, the Municipality of Claveria acknowledge the vital and important role of the Barangay Officials for the implementation of programs and projects of the National Government, Local Government and their respective Barangays;

WHEREAS, the present honoraria of the barangay officials in Claveria averaging to P4,000.00 per month for Punong Barangay and P3,500.00 per month for Barangay Kagawads, Secretaries and Treasurers is not compensable to their sacrifices and nature of work and sometimes their life is in danger due to the performance of their Duties and Responsibilities; and

WHEREAS, the Sanggunian, thru an ordinance may grant additional incentives and allowances to all barangay officials in the Municipality of Claveria to augment their honoraria which they believe may uplift their moral and eagerness to perform better their duties and responsibilities.

NOW THEREFORE, be it ordained in session assembled:

SECTION 1. SHORT TITLE – This Ordinance shall be known as **“THE BARANGAY INCENTIVE ORDINANCE OF 2021”**.

SECTION 2. DEFINITION OF TERMS – as used in this ordinance, the following terms shall mean:

- a. **Barangay Officials** – those elected and appointed barangay officials rendering services any time needed and receive only an honorarium; but not limited to, Punong Barangay, regular Sangguniang Barangay members, SK Chairman, Barangay Secretaries and Barangay Treasurers.
- b. **Incentive** – reward or something that encourages a person to do something, work harder or perform at higher level.

SECTION 3. REGULATIONS

- a. The Barangay Secretaries shall submit to the Municipality the List of their respective Barangay Officials with their corresponding Oath of Office attached and update correspondingly if there are changes.
- b. Every Punong Barangay shall receive an incentive amounting to Seven Hundred Pesos (P700.00) each per month.
- c. Every regular Sangguniang Barangay member, SK Chairman, Barangay Secretary and Barangay Treasurer shall receive an incentive amounting to Three Hundred Fifty Pesos (P350.00) each per month.

- d. The incentives of Barangay Officials shall be given on a semi-annual basis.
- e. Barangay Officials convicted with final judgment (administrative, civil, criminal), and or absence without leave, on vacation leave are not entitled in this program.
- f. The Municipal Mayor may increase the above stated incentives of qualified barangay officials, two (2) years thereafter but not more than 20%.

SECTION 4. FUNDS – The funds needed in this ordinance shall be included in the 2022 Annual General Fund Budget of the municipality and for the succeeding budget year hereafter. All disbursement of fund shall be subjected to usual accounting and auditing procedures as mandated by law.

SECTION 5. SEPARABILITY CLAUSE – If, or any reason/s, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provisions thereof which are not affected hereby shall continue to be in full force and effect.

SECTION 6. REPEALING CLAUSE – All ordinances, circulars, orders and rules and regulations inconsistent with this ordinance are hereby repealed and/or modified accordingly.

SECTION 7. EFFECTIVITY – This ordinance shall take effect on January 01, 2022.




