Maria, Sto. Nino and Taggat Sur, Claveria, Cagayan.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Local Government Unit of Claveria, now invites bids for the Procurement of Construction Materials and Equipment Rentals for the Concreting of Barangay Roads at Alimoan, Bacsay Cataraoan Norte, Bacsay Cataraoan Sur, Bacsay

Mapula-pula, Bilibigao, Buenavista, Dibalio, Lablabig, Pata East, Pata West, Pinas, Santiago, San Vicente, Sta. Maria, Sto. Nino and Taggat Sur, Claveria, Cagayan. Completion of the Works is required within thirty (30) Calendar Days upon receipt of Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the Implementing Rules & Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act".

Bids must be delivered to the address below on or before 9:30 AM of July 17, 2018. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

The Municipality of Claveria, Cagayan will hold a Pre-Bid Conference at 9:30 AM on July 3, 2018 at the BAC Office, 1st Floor, Municipal Hall, Claveria, Cagayan which shall be open to all interested parties.

Bids will be opened at 9:45 AM on July 17, 2018 at the BAC Office, 1st Floor, Municipal Hall, Claveria, Cagayan in the presence of bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.

The Local Government Unit of Claveria reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids at any time prior to contract award, without whereby incurring any liability to the affected bids or bidders.
